The protests in July and August 2024 and their aftermath

1. The protests in July and August 2024

1.1 Overview of events

On 5 June 2024, the Bangladesh High Court (HC) overturned a 2018 government decision to abolish a quota system for civil service jobs.¹ Consequently, the HC reinstated the quota system,² which reserved 30 % of civil service jobs for veterans of the 1971 Bangladesh’s war of independence and their children and grandchildren.³ The HC’s decision triggered nationwide student-led protests.⁴ On 21 July 2024, the HC issued a new judgement reducing the quota from 30 % to 5 %, ⁵ but the protests continued through July 2024 until the beginning of August 2024⁶ and eventually led to the resignation of the government.⁷

As a reaction to the reinstatement of the quota system, student-led protests started on 1 July 2024,⁸ with demands of a fair, merit-based system, as reported by Al Jazeera.⁹ According to the same source this ‘countrywide movement to reform the quota system, became known as “Students Against Discrimination.”’¹⁰ The protests started as a peaceful movement in universities, but ‘descended into violence’ by mid-July 2024 as reported by the Armed Conflict Location and Events Data Project (ACLED), when protest groups and police clashed.¹¹ According to the same source the student wing of the ruling party further escalated the violence by attacking demonstrators.¹²

On 15 July 2024, Bangladesh's prime minister Sheikh Hasina called the student protesters “Razakars”,¹³ a term allegedly considered ‘offensive, describing those accused of collaborating with Pakistan's army during the 1971 liberation war’ as reported by Al Jazeera.¹⁴ Hasina’s remarks intensified protests.¹⁵

After violent clashes led to hundreds of deaths,¹⁶ the government imposed an internet shutdown on 18 July 2024,¹⁷ cutting off Bangladesh from the global network.¹⁸ The government restored the internet after 11 days.¹⁹ However, social media platforms remained restricted.²⁰

Sources recorded 67 people having been killed on 19 July 2024 alone.²¹ The week of protests was described as ‘violent week’ by BenarNews.²²

To curtail protests, on 20 July 2024, the government deployed military forces²³ and imposed a national curfew²⁴ with a shoot-on-sight order.²⁵ There were also reports of the police firing tear gas and rubber bullets against protesters.²⁶ On 25 July 2024, Amnesty International (AI) verified three video-recorded incidents of law enforcement agencies making use of ‘lethal and less lethal weapons’ while policing the protests, and actions that ‘clearly constitute unlawful

and unnecessary use of force.²⁷ The government relaxed the curfew on 26 July 2024²⁸ and then extended it indefinitely from 5 August 2024.²⁹

On 1 August 2024, the Awami League government accused Jamaat-e-Islami party for allegedly inciting violence during student protests and issued a ban on the party³⁰ citing party's alleged 'threat to public security'.³¹

Between 4 August 2024 and 6 August 2024, 326 people were killed during protests as recorded by Prothom Alo.³²

On 5 August 2024, Bangladesh's prime minister Sheikh Hasina resigned and fled the country to India³³ after being in power since 2019.³⁴ Following Hasina's resignation, the Parliament was dissolved³⁵ and an interim government was installed on 8 August 2024³⁶ with the Nobel Peace Prize laureate Muhammad Yunus as the leader of the interim government.³⁷

According to the Preliminary Analysis of Recent Protests and Unrest in Bangladesh report, published by the United Nations Office of the High Commissioner for Human Rights (UN OHCHR) on 16 August 2024, there were allegations of human rights violations being committed by security forces, and UN OHCHR further stated that security forces used unnecessary and disproportionate force when handling the situation. According to the same source there were allegations of the security forces being responsible for extrajudicial killings, mass arrests, torture, and other ill-treatment.³⁸ Other sources also reported on mass arrests.³⁹

The Guardian reported that students accused law enforcement of torturing protesters while in detention⁴⁰ and the RFK noted large-scale arrests of protesters ‘while torture in custody is a norm of the law enforcement agencies.’⁴¹

On 13 August 2024 the Bangladesh Telecommunication Regulatory Commission (BTRC) confirmed that the decision to shut down internet during the protests was imposed by the Awami League government to allegedly ‘fulfil political interests’, as reported by the Daily Star.⁴² According to the findings of the probe committee on the internet blackout, former minister for Information and Communication Technology (ICT), Zunaid Ahmed Palak ordered the internet shutdown.⁴³ Reuters described the internet shutdown as ‘a tactic [...] employed previously at refugee camps and ahead of elections.’⁴⁴

On 23 August 2024, the interim government revoked the passport of the former prime minister Hasina.⁴⁵

As reported by Al Jazeera in September 2024, the interim government started Hasina’s extradition process,⁴⁶ carried out under the extradition treaty between Bangladesh and India.⁴⁷

1.2 Violence during the protests

Some sources have referred to the violent suppression of the protests in July and August 2024 as the ‘July massacre’.⁴⁸ According to UN OHCHR, which referred to public media reports and reports from the protest movement, over 600 people were killed between 16 July–11 August 2024, although stating that the death toll is ‘likely an underestimate’ as information collection was hindered due to the curfew and internet shutdown. Among those killed were protesters, bystanders, journalists, and members of the security forces, as well as 32 children. Thousands of people were believed to have been injured. Most deaths and injuries were attributed to the security forces and the Awami League’s student wing, according to the same source.⁴⁹

On 29 August 2024, the Health Adviser to the interim government, Nurjahan Begum claimed that '[...] more than a 1 000 people were killed and over 400 blinded during the recent anti-discrimination movement.'⁵⁰

On 24 September 2024, the interim government published a list of 708 people killed in nationwide protests between July and August 2024.⁵¹ The local human rights organisation, Ain o Salish Kendra (ASK), recorded 885 deaths between 16 July and August 2024 during the Student Movement of Anti-Discrimination.⁵²

On 17 October 2024, the Bangladesh International Crimes Tribunal (Bangladesh-ICT) issued an arrest warrant against Hasina for alleged crimes against humanity committed during the July-August 2024 uprising.⁵³ As reported by the Daily Star '[...] over 60 complaints of crimes against humanity and genocide have been filed against Hasina and many of her party men with the [Bangladesh-] ICT investigation agency and the prosecution team.'⁵⁴ Hasina was ordered to appear in court on 18 November 2024.⁵⁵

2. Aftermath of the protests and the change of government

2.1 The interim government and its reforms

The interim government is composed of Muhammad Yunus as the leader of the government, nominated by the military and student leaders⁵⁶ and its cabinet of advisers represented by, *inter alia*, former high-level government officials, lawyers, academics, human rights activists, and student activists.⁵⁷ According to an independent global think tank Observer Research Foundation (ORF), the Awami League is not represented in the cabinet.⁵⁸ As reported by the Deutsche Welle (DW), the primary mandate of the interim government is '[...] to ensure free and fair elections.'⁵⁹ Yunus reportedly claimed that elections '[...] will take place as soon as reforms in the election commission, judiciary, civil administration, and security forces are made.'⁶⁰ As of 31 October 2024, no elections date was announced by the interim government.

Within the reference period of this COI query response (15 May to 31 October 2024), the interim government took the following decisions:

- 13 August 2024: cancelled the National Mourning Day,⁶¹ commemorating the assassination of the former president of Bangladesh (and Sheikh Hasina's father⁶²) Sheikh Mujibur Rahman⁶³ also referred to as Bangabandhu - Father of the Nation.⁶⁴
- 28 August 2024: lifted the ban on Jamaat-e-Islami party.⁶⁵
- 29 August 2024: signed the International Convention for the Protection of All Persons from Enforced Disappearances⁶⁶ and enacted an Enforced Disappearance Inquiry Commission to investigate enforced disappearances between 1 January 2010 and 5 August 2024.⁶⁷
- 9 September 2024: revoked the 2009 Father of the Nation Family Members' Security Act.⁶⁸ The law was providing special protection and privileges to the family members of Bangabandhu Sheikh Mujibur Rahman.⁶⁹
- 28 September 2024: dissolved a committee mandated to revise the textbooks under the National Curriculum and Textbook Board.⁷⁰ Transparency International Bangladesh (TIB) expressed concern about the government's decision.⁷¹ As stated by the TIB Executive Director Iftekhar Zaman '[...] the cancellation of the coordination committee represents concession to fundamentalism and communalism but also betrays the very aspirations of New Bangladesh for a non-discriminatory, non-communal, and democratic future.'⁷²
- 30 September 2024: made an announcement that cases related to speech-based offences filed under cyber laws, including the 2006 Information and Communication Technology (ICT) Act, the 2018 Digital Security Act (DSA), and the 2023 Cyber Security

Act (CSA) are revoked⁷³ and people in custody under such cases will be released through legal procedures.⁷⁴ Sources reported that as of September 2024, there were 1 340 ongoing cases related to speech offences, including 461 cases under investigation, while 879 under trial in the country's eight cyber tribunals.⁷⁵ The speech offence cases included 279 filed under the ICT Act, 786 under the DSA, and 275 under the CSA.⁷⁶ International organisations and activists demanded a repeal of the CSA.⁷⁷

- 4 October 2024: formed five commissions, including Public Administration Reform Commission, Anti-Corruption Reform Commission, Judiciary Reform Commission, the Electoral System Reform Commission and the Police Reform Commission.⁷⁸ Each commission will include a student representative.⁷⁹
- 5 October 2024⁸⁰ and 19 October 2024⁸¹: initiated a round of discussions with political parties on state reforms.
- 7 October 2024: enacted the Constitution Reform Commission to review and evaluate the constitution.⁸² Some academics, researchers, and journalists expressed the need for recognition of pluralism and inclusivity of Bangladesh in the constitution, as reported by Dhaka Tribune.⁸³ According to Robayet Ferdous, professor in the Department of Mass Communication and Journalism at Dhaka University, the constitution 'does not reflect the pluralistic and multicultural reality of Bangladesh.'⁸⁴

As reported by Dhaka Tribune, a new political party called Bangladesh Popular Party was launched on 23 September 2024, which pledges 'to protect the democracy and sovereignty of Bangladesh.'⁸⁵

2.2 Reform of the justice system

On 25 September 2024, the Supreme Court launched a helpline, providing guidance on litigation services and filing complaints.⁸⁶

Under article 98 of the Bangladesh's constitution,⁸⁷ on 8 October 2024, the government appointed 23 new judges to the HC, raising the number to 101.⁸⁸ The new judges took oath on 9 October 2024 and started their tenure.⁸⁹ On 16 October 2024, 12 judges appointed under Awami League government were placed on leave by the Chief Justice of HC amidst students' demonstration on the HC premises.⁹⁰

2.3 Reform of the law enforcement

While on 22 August 2024 three senior police officers, including two additional inspectors general of police were sent on forced retirement,⁹¹ on 27 August 2024 five police officials sent to retirement by the Awami League government were reinstated.⁹² As reported by the Daily Star, the reinstated police officials had been put on forced retirement by the Awami League government citing "public interest."⁹³

Established on 4 October 2024, the Police Reform Commission aims to develop a proposal to change the police into a 'pro-people force.'⁹⁴ The appointed members of the Commission include Chowdhury Rafiqul Abrar, the president of Odhikar, a prominent local human rights organisation.⁹⁵

2.4 Accountability for conduct by law enforcement under the previous government

Since its establishment in August 2024 and within two weeks of operations, the inquiry commission for enforced disappearances received 400 complaints, mostly filed against Detective Branch (DB), Rapid Action Battalion (RAB), Directorate General of Forces Intelligence (DGFI) and Counter Terrorism and Transnational Crime (CTTC).⁹⁶ Moreover, the Commission

confirmed the location of the detention centre and the Joint Interrogation Cell (JIC) known as Aynaghar inside the DGFI headquarters.⁹⁷ Run by the DGFI, Aynaghar also referred to as “House of Mirrors” was a detention facility where ‘victims of enforced disappearances’ were held in allegedly inhuman conditions over the last one and a half decades as reported by the Daily Star.⁹⁸ As indicated by Human Rights Watch, since 2009, Bangladeshi human rights monitors documented about 600 cases of alleged enforced disappearances.⁹⁹ The local human rights organisation Odhikar recorded 798 cases of enforced disappearances in the period 2009–June 2024.¹⁰⁰

In October 2024, the Director General (DG) of the RAB stated that the ‘Rab will never again get involved in incidents such as enforced disappearances and extrajudicial killings.’¹⁰¹ According to the DG, the ‘RAB will not be involved in [...] any unlawful actions’¹⁰² and will comply with the existing legal framework, including the internationally recognised human rights standards.¹⁰³ Moreover, the DG confirmed RAB’s cooperation with the UN fact-finding team on their ongoing investigation on alleged human rights abuses in Bangladesh.¹⁰⁴

As reported by sources in the July 2024 EUAA Bangladesh report, the former government used law enforcement as a tool for its own agenda, and *inter alia* the RAB committed human rights abuses such as extrajudicial killings, enforced disappearances, and torture.¹⁰⁵

Key figures within the previous government gave their tacit approval for abuses ‘at the very least.’ According to one RAB whistleblower interviewed by DW, operations went ahead after being ‘explicitly sanctioned from above’, including from the Ministry of Home Affairs or the Minister of Home Affairs.¹⁰⁶

On 11 September 2024, during the 57th regular session of the UN Human Rights Council, the Asian Forum for Human Rights and Development (FORUM-ASIA) and Amnesty International expressed concern about the existence of systems that have long enabled human rights violations [in Bangladesh] and impunity for these violations and the lack of public confidence in state institutions.¹⁰⁷

3. Targeted violence and arrests

On 19 August 2024, a group of international organisations released a joint letter requesting the UN Human Rights Council to investigate the violent incidents in July and August 2024 and to monitor the situation in Bangladesh.¹⁰⁸ A UN fact-finding team arrived in Bangladesh on 14 September for a month-long visit.¹⁰⁹

3.1 Journalists

Some journalists reporting on July-August 2024 protests were killed,¹¹⁰ attacked,¹¹¹ and arrested by police.¹¹² As indicated by the Coalition For Women In Journalism (CFWIJ), women journalists were subjected to alleged targeted attacks by ‘police, opposition party supporters, and protestors.’¹¹³

According to Reporters Without Borders (RSF), Committee to Protect Journalists (CPJ), and International Federation of Journalists (IFJ) South Asia Media Hub, two journalists were killed during the protests in July 2024,¹¹⁴ while Voice of America (VoA) reported on five killed journalists in July and August 2024.¹¹⁵ According to RSF, 250 journalists were injured in the former government’s crackdown on the protests.¹¹⁶

After the fall of Sheikh Hasina, journalists were targeted by protesters¹¹⁷ with the UN and RSF requesting the interim government to protect journalists.¹¹⁸ Sources reported on arrest and

charges of journalists affiliated with the former government.¹¹⁹ On 29 August 2024, over 24 journalists were charged with crimes against humanity and genocide¹²⁰ for allegedly ‘[...] publishing false news to instigate the genocide and crimes against humanity committed by the then government and law enforcers’ as reported by the Daily Star.¹²¹ RSF condemned the ‘outrageous’ charges and called it a form of ‘judicial harassment’ and ‘purge’ of journalists perceived as affiliated with the former government.¹²²

On 15 October 2024, RSF called on the interim government to abolish the CSA and drop charges against media professionals under repressive laws (including the CSA, the DSA, and the ICT) of the former government that were used to suppress critical voices.¹²³ According to the same source, there were at least seven media professionals awaiting trial under cybersecurity laws.¹²⁴

To ensure freedom of press,¹²⁵ the interim government announced the creation of the Mass Media Commission on 17 October 2024.¹²⁶

3.2 Members and supporters of the Awami League Party

After the fall of the Hasina-led government on 5 August 2024, sources reported on protesters vandalising the houses of senior government officials and setting their homes on fire.¹²⁷ According to local media, the protesters attacked governmental offices and private properties

of high-level officials.¹²⁸ While some Awami League members went into hiding,¹²⁹ 29 Awami League members and their families were reportedly killed.¹³⁰

Between August 2024 and October 2024, the Bangladesh Financial Intelligence Unit (BFIU) instructed banks to freeze the accounts of former high-level officials (including former finance minister, former social welfare minister, former director general of the National Telecommunication Monitoring Centre) and their family members.¹³¹

In the same period, a Dhaka court issued and imposed travel bans on former Awami League ministers and high-level officials and their families,¹³² including former director general of the National Security Intelligence and former chief of the DB.¹³³

According to VoA, immediately after Hasina's fall, many supporters of the former government fled Bangladesh for India, the United States, Canada, the U.K., Türkiye and other countries.¹³⁴

On 6 October 2024, one high-level official was detained when trying to leave Bangladesh for India.¹³⁵ Sources reported on arrests of two former ministers on 14 October 2024.¹³⁶ On 17 October 2024, the Bangladesh-ICT issued arrest warrants for 45 Awami League top officials.¹³⁷

3.3 Religious minorities

On 6 August 2024, the European Union Delegation to Bangladesh expressed concern about ‘reports of multiple attacks against places of worship and members of religious, ethnic and other minorities in Bangladesh.’¹³⁸ Upon the resignation of Sheikh Hasina, attacks on religious minorities, specifically on Hindu temples and properties, were reportedly carried out,¹³⁹ allegedly by mobs.¹⁴⁰ The violence against the Hindu community resulted in protests held in Dhaka on 9 August 2024¹⁴¹ and in Bogra on 11 August 2024.¹⁴²

Acts of violence against Hindu community, including vandalism and looting of Hindu temples, homes, and businesses continued to be reported between August 2024 and October 2024.¹⁴³ According to ‘some analysts many of the attacks against Hindus are politically driven and reflect resentment against Hasina’s party’ as reported by AP.¹⁴⁴

There was also disinformation circulating about Hindus being targeted,¹⁴⁵ including false claims of rape and sexual harassment of Hindu women, as reported by DW,¹⁴⁶ and a cricket star having his home burnt.¹⁴⁷

3.4 Rohingyas from Myanmar

In his first policy speech, on 18 August 2024, Yunus promised support to Rohingya refugees living in Bangladesh as reported by Al Jazeera.¹⁴⁸ In a September 2024 meeting with the International Organization for Migration (IOM), Yunus called for an expedited resettlement

process of Rohingyas from Bangladesh to third countries¹⁴⁹ as around 8 000 Rohingyas fled to Bangladesh in recent months¹⁵⁰ due to escalated violence in Myanmar.¹⁵¹

3.5 Mob lynching

Between 11 August and 19 September 2024, 21 people were reportedly lynched according to media sources,¹⁵² while ASK recorded 28 deaths in mob beatings between August 2024 and September 2024.¹⁵³ Although in September 2024, the interim government adopted a ‘zero-tolerance policy against extrajudicial killings, assaults, and harassment’ as reported by Dhaka Tribune,¹⁵⁴ in October 2024, JusticeMakers Bangladesh (JMBF) expressed concern about the rise in mob violence and killings¹⁵⁵ and called the government for judicial investigation.¹⁵⁶
