## COI QUERY RESPONSE – Iraq

### Dissolution of the Kurdistan Workers' Party (PKK) in May 2025 and aftermath in Erbil

For background information on the PKK in Iraq and the security situation in the Kurdistan Region of Iraq (KRI), in particular in Erbil, see the EUAA COI report titled [Iraq - Security Situation](#) (pp. 36-37 and 109-115), published in May 2024.

Turkish strikes on the KRI continued to be reported in early 2025; in January, a strike, allegedly targeting PKK, killed six people.<sup>1</sup> On 1 March 2025, after 40 years of conflict, the PKK declared a ceasefire with Türkiye, stating that 'none of our forces will take armed action unless attacked'.<sup>2</sup> Nevertheless, armed incidents continued to be reported after the ceasefire was announced.<sup>3</sup> The Community Peacemaker Teams (CPT), a US-based NGO monitoring security incidents in the KRI, recorded approximately 118 Turkish attacks in March 2025, including 86 airstrikes, with Erbil and Duhok being the most targeted governorates.<sup>4</sup> In April of this year, Medya News, citing local news sources, reported that Türkiye 'has significantly escalated its military operations in northern Iraq and the Kurdistan Region this month, carrying out over 1,500 cross-border attacks'.<sup>5</sup> Targeted areas included the regions of Duhok, Gare, Zap, Amadiya, the area of the Qandil mountains and nearby rural areas.<sup>6</sup> While no civilian casualties were reported, the attacks reportedly caused 'significant damage to homes, farmland, and civilian infrastructure'.<sup>7</sup>

On 12 May 2025, 'the PKK's 12th Congress decided to dissolve the PKK's organizational structure and end the armed struggle method',<sup>8</sup> indicating that the group will remain active as a political actor.<sup>9</sup> Information on specific aspects such as how the dissolution will take place in practice and whether Turkish troops withdraw from northern Iraq remained unclear when the announcement was published.<sup>10</sup> As of 18 May, the disarmament process 'remained uncertain', and conditioned on the withdrawal of Turkish troops that were still involved in military

operations in Zap and Metina.<sup>11</sup> As of May, the presence of Turkish forces in the KRI was estimated at 80 to 100 military outposts,<sup>12</sup> ‘housing thousands’ of troops.<sup>13</sup>

Information on the development in Erbil as of May 2025 could not be found among the sources consulted by EUAA within time constraints. However, the following information may be relevant.

Sources indicated that after both, the March ceasefire and the PKK dissolution was announced in May, Turkish attacks in the KRI continued.<sup>14</sup> On 15 May, Rudaw reported that Türkiye continued bombing targets and sending surveillance drones in the KRI.<sup>15</sup> During the last week of May, Shafaq News reported on 128 artillery attacks by Turkish forces in Amedi, with no reported civilian casualties.<sup>16</sup> Describing the period of three months after the ceasefire, the CPT reported that ‘Turkish strikes have surged significantly’, while adding that the attacks were concentrated in specific areas in the Duhok governorate, particularly the Amedi district.<sup>17</sup> The source recorded 510 bombardments and attacks by Turkish forces in May 2025, all of them in Duhok.<sup>18</sup> Between January and May 2025, the source recorded three killed and six wounded civilians.<sup>19</sup>
