## COI QUERY RESPONSE – Türkiye

### Situation of Turkish Kurds with real or perceived affiliation with the People's Protection Units (YPG) in Syria

#### 1. Background information on YPG and involvement of Kurds from Türkiye

The People's Protection Units (YPG) were formed in 2011 at the outset of the civil war in Syria,<sup>1</sup> and has been described by sources as the military wing of the Syria-based Kurdish Democratic Union Party (PYD).<sup>2</sup> Since 2015, YPG – mainly active in northern Syria<sup>3</sup> – has been the main component of the Syrian Democratic Forces (SDF),<sup>4</sup> a United States-backed military alliance established to counter the Islamic State of Iraq and the Levant (ISIL).<sup>5</sup> The Kurdish-led SDF<sup>6</sup> also included allied Arab groups and other factions.<sup>7</sup>

Specific information on the number of SDF and YPG members, as well as information on the number of Turkish citizens as members of the above groups, could not be found among the sources consulted by EUAA within time constraints of this query. According to International Crisis Group, the YPG included in its ranks several hundred non-Syrian PKK-trained members, which Türkiye viewed 'as a concern'.<sup>8</sup> According to its commander, the SDF comprised about 100 000 members at the beginning of 2025.<sup>9</sup> However, a December 2025 article by Reuters indicated that SDF had 'roughly 50 000 fighters'.<sup>10</sup> Moreover, according to sources, an armed group of foreign volunteers including Turkish citizens, called as International Freedom Battalion (IFB), operated under the YPG. The IFB was also composed of several armed groups, with the majority of them reportedly being Turkish 'Communist/Socialist revolutionary organisations',<sup>11</sup> including the Turkish-originated Marxist-Leninist Communist Party (MLKP).<sup>12</sup> An

academic article cited a 2015 publication by the Turkish newspaper Hürriyet, according to which 8 500 persons were estimated to have joined the YPG from Turkey.<sup>13</sup> More recent information could not be found among the sources consulted by EUAA within time constraints of this query.

## 2. Treatment by state

Information on the treatment by the Turkish state of Kurds with real or perceived affiliation with the People's Protection Units (YPG) was scarce among the sources consulted by EUAA within time constraints of this query. However, the following information may be relevant.

According to sources, Türkiye considers the YPG as an extension of the Kurdistan Workers' Party (PKK),<sup>14</sup> which is designated as a 'terrorist' group by Türkiye.<sup>15</sup> Due to the ties with PKK, Türkiye also views both the YPG<sup>16</sup> and the SDF as 'terrorist' organisations.<sup>17</sup>

Türkiye was reported to consider the quasi-autonomous SDF-ruled territories in northern Syria as its 'main security concern'<sup>18</sup> and as 'a direct threat to its national security'.<sup>19</sup> According to the Congressional Research Service (CRS), Turkish military operations in Syria were largely focused on the YPG, seeking to prevent the group from gaining territories<sup>20</sup> and 'establishing an autonomous area along Syria's northern border with Turkey'.<sup>21</sup>

Sources dated within the time frame of this query response noted that Turkish military and Turkish-backed militias have continued to carry out operations targeting Syrian Kurdish groups,<sup>22</sup> including YPG in northern Syria.<sup>23</sup> According to International Crisis Group, in the period 2023 – 2024, Türkiye intensified its operations against the YPG, often targeting

YPG/SDF targets and infrastructure in Syria as a response to PKK attacks in Türkiye or in Iraq.<sup>24</sup>

Moreover, in a December 2023 publication, the Federal Office for Migration and Refugees of Germany (BAMF) noted that, according to information by the Turkish Ministry of Defence, since the beginning of 2023 and as of 7 September 2023, state forces have killed or arrested more than 1 180 PKK or YPG members, including people who were in Iraq and northern Syria.<sup>25</sup> Further information on arrests of YPG members in Türkiye could not be found among the sources consulted by EUAA within time constraints of this query.

Following the PKK's formal announcement of the dissolution of the group in May 2025,<sup>26</sup> sources have cited Turkish officials stating that this applied to all groups associated with the PKK, including the YPG,<sup>27</sup> calling for its disbandment.<sup>28</sup> Sources dated in May 2025 indicated that SDF<sup>29</sup> or YPG have not taken a formal position on the PKK's disbandment decision.<sup>30</sup> However, prior to the call by Abdullah Öcalan, leader of PKK, for the dissolution and disarmament of the group in February 2025, the SDF commander stated that this call only related to PKK not to their own activities in Syria.<sup>31</sup> As of January 2026, the YPG was reportedly still active, as indicated by media sources.<sup>32</sup>

Following a March 2025 integration deal - not enacted due to a lack of implementation by the involved parties -, the Syrian government and SDF reached an agreement on 30 January 2026 including a ceasefire and the integration of Kurdish military forces and institutions into the state.<sup>33</sup> The head of YPG's media office told Rudaw that the group supported the continuation of the ceasefire, however stated that 'they will respond forcefully to any attacks by the Syrian Arab Army or its affiliated factions'.<sup>34</sup> The Turkish newspaper Daily Sabah noted that foreign non-Syrian YPG members were not included in the aforementioned integration agreement.<sup>35</sup>

Furthermore, Human Rights Watch (HRW) noted that due to the links of YPG and PKK, Kurdish people who resided under SDF rule, and who were thereby perceived as 'loyal to the SDF or to any of its various components, have overwhelmingly borne the brunt of the abuses documented' by Turkish armed forces and Turkish-allied groups in Turkish-occupied northern

Syria.<sup>36</sup> These human rights violations included abductions, torture, sexual violence, and extrajudicial killings, and detention-related abuses often occurred on suspicion of links with SDF, YPG, PKK, or affiliate groups.<sup>37</sup> According to the same source, other non-Kurdish individuals, as well as Arabs, who were perceived to have had ties with the SDF, were also targeted.<sup>38</sup>
