COI QUERY RESPONSE

SOUTH AFRICA - FOREIGNERS

A report issued in September 2024 by *Amnesty International* states that: "South Africa has a strong legal and human rights framework on refugees and asylum seekers' rights. However, the failed asylum management process, which has been well documented over the years, shows that the implementation of existing laws and policies, as well as court orders, is starkly lacking...The rights of asylum seekers and refugees, which are prescribed in law and policy, are being denied in various ways."

This document also states that: "Institutional xenophobia and anti-migrant bias are rife, exacerbating the vulnerable position of asylum seekers..."²

Agence France Presse in August 2024 points out that: "Hostility towards foreigners has increased in recent years, as South Africans tire of unwavering unemployment."³

In May 2024 *Reuters* comments: "...on the dire conditions endured by many Africans who arrive here searching for of a better life in the continent's most advanced economy, and the hostility they say they've encountered from South African authorities as well as bands of vigilantes who blame foreigners for taking jobs and services away from local people."⁴
